The EMS Region III Conference is an annual event that began as an EMS Trade Show in 1982 and transformed over the past 44 years into one of the premier conferences in this part of the country. This will be the 27th year the conference has been held in beautiful Ruidoso, New Mexico.

It is important to remember that the state has resumed its policy that only ½ of your required CE's can be obtained on-line (asynchronous). The remainder must be classroom (Synchronous).

This year's conference is designed to offer all of the State and National Registry CE requirements by providing pre-conference CE renewal packages, combined with a reduced core conference rate, for those participants trying to complete all required CE requirements at one venue.

Early Pick-up Conference Registration Name Badge

It is important to note when selecting the best method of obtaining CEs for re-licensure, that New Mexico no longer requires a traditional refresher course, but simply a minimum number of CE hours to renew your license.

The EMS Bureau's goal is to have a straightforward process of license renewal, while still requiring documentation of the maintenance and improvement of each licensee's knowledge base.

The New Mexico EMT license renewal process is now similar to that National Registry of EMT's National Continued Competency Program (NCCP) model for each level of licensure. By meeting the New Mexico requirements for license renewal, one should meet those of the National Registry, however please visit the NR website to assure your compliance with NR specific requirements. www.nremt.org

Six EMS CE categories are accepted by the New Mexico EMS Bureau and a seventh category, Emergency Medical Dispatch, was added to address the specific requirements of the EMD and EMD-I level of licensure:

- Emergency Medical Dispatch
- Preparatory/Operations
- Airway, Respiration & Ventilation
- Cardiovascular
- Medical
- Trauma
- Special Considerations

All pre-conference and core conference workshops have been designed with these new guidelines in mind and will hopefully make your re-licensure a little easier.

Pre-Conference Course Information (Applies to All Pre-Conference Courses)

If you see **REQUIRED ONLINE PRE-COURSE WORK** then it requires **mandatory online pre-course work** to be completed **prior to the first day of class**. Instructions and access information will be sent via **email** following registration. If you have not received pre-course information **within two (2) weeks of registration**, please check your **spam or junk email folder**, and/OR contact the **EMS Region 3 Office** for assistance.

Email Communication & Registration Accuracy

All course-related information—including pre-course requirements, location details, and certificate notifications—will be sent **to the email address provided at registration**.

Each registered student must have **their own individual email address** on file. If a shared, manager, or agency email address is used, the registrant assumes responsibility for **ensuring all information is promptly forwarded to the student**.

EMS Region 3 is not responsible for missed communications due to shared email accounts, failure to forward information, or incorrect email entry.

Registration & Course Locations

All students must report to the **Convention Center for initial conference registration**, regardless of course location.

Certain courses will be held at **off-site**. Courses held at alternative locations will be identified in the course description. Location details will be provided during on-site registration.

Students traveling with others are responsible for ensuring appropriate transportation arrangements for off-site courses.

Certificates & Continuing Education Credit

Renewal Courses

Certificates for renewal courses are **not automatically mailed**. Certificates may be requested through the **EMS Region 3**, if needed. All continuing education hours (CEs) will be **uploaded to the New Mexico EMS Portal** upon confirmation of course completion and payment.

Certificate-Based Courses

For certificate-based courses (including **PHTLS, EPC, and TECC**), certificates will be **emailed to the student** upon confirmation of successful course completion and payment. Please allow the **EMS Region 3 through the end of May** to complete post-conference processing.

Attendance Requirements

Full attendance is required for all pre-conference courses. Students must attend **all scheduled portions**, including lectures, skills sessions, and testing. Failure to meet attendance requirements, including late arrival or early departure, may result in **ineligibility for course completion**, including denial of certificates and/or continuing education credit.

Wilderness EMS Upgrade Medical Course (WEMS) \$100

This **Wilderness EMS Upgrade (WEMS)** course is a comprehensive **45-hour training program** (including required pre-course online work) designed for **all levels of medical licensure—from First Responder through Paramedic and Nursing—who operate in remote, austere, or prolonged-care environments.**

WEMS is advanced wilderness and austere medicine training designed to extend the reach of EMS providers operating within New Mexico's expanded wilderness scope—preparing them to manage patients when **transport is delayed, resources are limited, and the environment becomes part of the problem.**

This course is especially valuable for **rural EMS providers, search and rescue teams, law enforcement, and any medical professional who cannot reliably deliver patients to a hospital within two hours of injury or illness onset.** Emphasis is placed on **prolonged patient care, severe environmental exposure, clinical decision-making with limited resources, and improvised medical solutions.**

Training is **fast-paced, hands-on, and scenario-driven**, incorporating realistic simulations and practical skills application throughout the week.

Certification & Credit

Successful completion results in a **nationally recognized Wilderness Medical Associates certification**, tailored to licensure level:

- **First Responders:** Wilderness First Responder (WFR) certification
- **EMTs and higher:** Wilderness EMT / Wilderness EMS certification
- **Nurses:** 45 contact hours approved by the **California Board of Registered Nursing**
- **NM & CAPSE CE credits awarded**

Medical direction means guidance or supervision provided by a physician to a provider or Emergency Medical Services system and which includes authority over and responsibility for Emergency Medical Dispatch, direct patient care and transport of patients, arrangements for medical control and all other aspects of patient care delivered by a provider.

Medical control is required for certain skills and medications used at all levels of EMS as outlined in the New Mexico scopes of practice. Those EMS personnel who function without medical direction shall only perform those skills, techniques and procedures that do not require medical director's approval. Any person who is issued a temporary or graduate license shall only administer the medications or perform the skills, techniques, medications and procedures for the approved level, as established by the medical direction committee and found in the applicable scope of practice.

It is mandatory¹ that all Medical Directors complete a nationally recognized EMS Medical Director's course; or a Bureau-recognized orientation course; or a local orientation provided by a regional or State EMS Medical Director. This course satisfies the requirements for Medical Direction for the State of New Mexico.

The New Mexico EMS system consists of 345 EMS and Fire Services and over 8,000 licensed medical technicians. They respond to approximately 380,000 requests for service [encounters (runs)] each year. EMS services may apply for a state appropriation from the EMS Fund Act, which provides \$3.2 million per year to help underwrite the EMS services in the State. Receipt of these funds is dependent on a number of parameters, including the number of EMS runs a service makes each year, level of responders' training, geographical area covered and population served.

This year the application process has been changed to an online format through the Licensing Portal. In this session, we will cover the new application process and answer Fund Act and other Bureau questions. If you are responsible for the funding for your service, you don't want to miss out on this session. The remainder of the session will be spent on training/issues and questions/answers on the NMEMSTARS Elite data reporting system and the Licensing Management Portal.

This hands-on Advanced Airway Management course is designed for experienced, licensed paramedics seeking to refine and elevate their airway management skills in high-acuity, prehospital environments. Low Volume/High Stakes: The Frontier Provider's Guide To Decision-Making

You run two calls a day. A week? One is a fall. The other is a dialysis transfer. Your last cardiac arrest was six months ago. Your last pediatric intubation was never. When the critical call comes, you won't have muscle memory to fall back on. You'll have protocols, whatever equipment and training your time and budget allowed, and the sinking feeling that you're making decisions with incomplete information and no backup.

Welcome to low volume EMS.

Rural, remote, frontier, volunteer, and small-town providers face a paradox: the same clinical stakes as high-volume urban systems, but without the repetition that builds and maintains competence or confidence. You cannot practice what you never see. You can't refine skills through volume when volume doesn't exist. And when the big call comes, there's no cavalry. It is just you, your partner, and whatever you can improvise in the back of a truck on a dirt road an hour from definitive care.

This session isn't about wishing you had more resources. It's about making better decisions with what you actually have.

We'll examine clinical decision-making in resource deserts: how to think like a detective when labs and imaging aren't coming, when to trust your gut versus when to override it, when protocols don't fit your reality and you have to improvise, and how to build clinical reasoning without high call volume.

Hypothermia destabilizes the heart. Frostbite hides progressive tissue destruction. Avalanche victims often die from what happens next: reperfusion, crush injury, rhabdomyolysis, and electrolyte collapse. Using response scenarios brought from home in Alaska, this session examines the pathophysiology and field management of cold injuries, with emphasis on the second phase of danger, the post-rescue collapse. The discussion extends beyond obvious wilderness calls to the cold patients crews miss: hypothermia from medical illness,

incidental exposure, and abuse or neglect. Designed for rural EMS, SAR, and austere responders, this talk focuses on recognition, packaging, rewarming decisions, and transport priorities when cold, compression, and hypoxia intersect..

Our Master of Ceremonies will be Dr. Craig Rhyne.

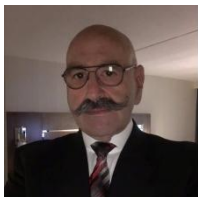
